However, if my treatment is for the sole purpose of creating health information for disclosure to the recipient identified in this authorization, Norton Medical Center may refuse to treat me if I do not sign this authorization. I have the right to see and copy the information on this form or ask for another signed copy of the form at anytime within six years of its expiration date.

Right to Revoke Authorization - I understand written notice is necessary to revoke this authorization. I am aware that revoking my authorization will not affect any information previously released with an authorization.
