



How to Obtain a Driver's License/State ID

1. You will need the following:

- A valid passport, visa and I-20
- Your most recent I-94. This can be printed it from [here](#)
- An **Enrollment Verification Letter** from the Registrar's office (Please make sure it includes your updated current address!)
- A **valid Social Security Card** or **Denial Letter** from the Social Security Administration.
- A Student ID Card from Wheaton College
- Money (approximately **\$50**, varies by state, not including road tests and extra fees) to take the Written Exam (Get the Driver's Manual from the DMV Office [here](#) and go to page 151.

2. Go to RMV office, present your documents, pay fees and take the written exam

3. Once you pass the written exam, you can schedule a road test within 3 months. Please Hold on to your test card because it also serves as your driving permit. The license costs approximately \$50.

Important from the Massachusetts Registry of Motor Vehicles (RMV):

Foreign license holders who wish to drive in Massachusetts are subject to the following requirements:

- Must be at least 16 years of age
- Must be in possession of a valid driver's license from their home country
- May drive a vehicle in Massachusetts of the same class indicated on the foreign license
- Must have either an International Driving Permit (IDP) or the *Translation into English of a Foreign Driver License* which is an acceptable alternative document if the foreign license is not in English or does not have an English translation
- Driver's license must not be suspended or revoked

IDPs and Acceptable Alternative Documents

An International Driving Permit (IDP) is a translation of a driver's license into 10 major languages. It does not convey any driving privileges but must accompany a foreign license if the license is not in English.

If a foreign-licensed driver does not have an IDP, the license holder must obtain the *Translation into English of a Foreign Driver License* alternative document that properly identifies the license holder and translates the relevant license information into English. This form can be found on [Mass.gov/RMV](https://www.mass.gov/RMV) in the "Learner's permit, driver's license and ID card forms" section, <https://www.mass.gov/service-details/driving-in-massachusetts-on-a-foreign-drivers-license>.

Either an IDP or the alternative document must accompany any foreign license that is not in English.

Final notes:

“If you are a visitor from another country, you may drive private passenger vehicles in Massachusetts for up to **one year from your date of arrival in the United States** provided you have a valid driver's license issued by your home country and your country is recognized under one of the conventions listed on page 151 – 152 in the driver's manual seen above.”
